

# Calilio Partner Program Terms & Conditions

CURRENT AS OF 01 JAN 2026

## 1 Definitions

- 1.1 "Calilio," "we," "us," "our": Refers to Calilio and its operators.
- 1.2 "Affiliate," "Partner," "you": Refers to the individual or entity participating in the Program.
- 1.3 "Customer": A new, unique user referred by you who purchases a paid Calilio workspace subscription.
- 1.4 "Qualified Referral": A Customer who (i) clicks your unique tracking link, (ii) signs up for a Calilio account within the 90-day Attribution Window, and (iii) subsequently makes a full payment for any paid Standard or Business plan (monthly or annual).
- 1.5 "Attribution Window": 90 days from the click on your affiliate link.
- 1.6 "Commission": The fee earned for a Qualified Referral, calculated as 30% of the net revenue actually received by Calilio from the Customer's subscription payments.
- 1.7 "Lifetime Commission": Commissions earned for the entire duration of a Qualified Referral remain a paying Customer on any paid plan, subject to the terms of this Agreement.

## 2 Introduction

You must apply through our designated platform, PartnerStack. Approval is at Calilio's sole discretion. You must provide accurate information. Each partner is allowed one account.

## 3 Commission Structure

- 3.1 **Earning Commission**  
You will earn a 30% Lifetime Commission on all workspace revenue received from each Qualified Referral. This applies to all paid Standard and Business plans, whether monthly or annual, and includes upgrades/downgrades.
- 3.2 **Commission Calculation**  
Commissions are based on the actual deal amount received by Calilio, refunds, chargebacks.
- 3.3 **Lifetime Term**  
Lifetime" means for as long as the Qualified Referral continues to pay subscription fees to Calilio. This continues even if you become inactive in the Program, provided your account is in good standing.
- 3.4 **Commission Cessation**  
Commissions will stop if a Customer: (a) receives a full refund; (b) switches to a free plan; (c) fails to pay; or (d) is terminated for violation of Calilio's terms.

## 4 Payment

- 4.1 **Payment Threshold**  
Payments are issued when your balance reaches a minimum of USD \$5.00.
- 4.2 **Payment Method**  
Payments are processed via the options available in the PartnerStack platform.
- 4.3 **Payment Fees**  
Any transaction fees imposed by the payment processor (e.g., PartnerStack, PayPal, bank transfer) for sending your commission are your responsibility and will be deducted from your payment.
- 4.4 **Payment Schedule**  
Commissions are tracked in real-time. Paid commissions are processed in 1 to 12 cycles depending upon monthly and yearly plans. Commissions are paid out approximately 30 days after the end of the month in which the Customer's payment was received.
- 4.5 **Taxes**  
You are solely responsible for reporting and paying any income, VAT, or other taxes applicable to your Commissions in your jurisdiction. Calilio will not withhold taxes unless legally required.

## 5 Promotional Guidelines & Compliance

- 5.1 **Permitted Promotion**  
You may promote Calilio through ethical marketing methods, including your website, social media, email lists, and videos, provided you comply with all applicable laws (including GDPR, CCPA, and anti-spam laws) and this Agreement.
- 5.2 **Prohibited Activities: You MUST NOT:**
  - ✓ Engage in spam, misleading advertising, or unauthorized commercial emails.
  - ✓ Use violent content, infringing materials, or make false claims about Calilio.
  - ✓ Engage in trademark infringement, brand bidding (unless explicitly authorized in the future), or typosquatting.
  - ✓ Create fake accounts, self-refer, or engage in any fraudulent activity.
  - ✓ Use malware, forced clicks, or automated software.
- 5.3 **Brand Assets**  
You may use marketing materials (logos, banners, links) provided in the PartnerStack portal. You may also create your own materials, provided they adhere to Calilio's brand guidelines (to be provided separately) and are professional and truthful.

## 6 Termination

Calilio may terminate this Agreement and your participation in the Program at any time, with or without cause, and at its sole discretion. In addition, if Calilio determines that any of your actions, content, or promotional activities harm or may potentially harm Calilio's brand, reputation, goodwill, or business interests, Calilio reserves the right to immediately suspend or permanently ban your Partner account without prior notice and without any obligation to disclose the reason for such action.

Upon termination:

- ✓ You must immediately cease using all Calilio trademarks and promotional links.
- ✓ You will be paid all accrued, eligible Commissions above the payment threshold.
- ✓ **For Cause Termination:**  
If termination is due to your violation of this Agreement or fraudulent activity, Calilio reserves the right to forfeit and void all pending and accrued Commissions, not just future ones.

## 7 Modification

Calilio reserves the right to modify any part of this Agreement, including Commission rates, payment schedules, and program rules, at any time and at our sole discretion. Modifications may be made with or without prior notice. Your continued participation in the Program after changes are posted constitutes your acceptance of the new terms.

## 8 Disclaimer & Limitation of Liability

THE PROGRAM AND COMMISSIONS ARE PROVIDED "AS IS." CALILIO DISCLAIMS ALL WARRANTIES. WE WILL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES ARISING FROM THE PROGRAM. OUR MAXIMUM AGGREGATE LIABILITY UNDER THIS AGREEMENT IS LIMITED TO THE TOTAL COMMISSIONS PAID TO YOU IN THE SIX (6) MONTHS PRIOR TO THE EVENT GIVING RISE TO LIABILITY.

## 9 Governing Law & Disputes

This Agreement shall be governed by and construed in accordance with the laws of Singapore. Any disputes shall be subject to the exclusive jurisdiction of the courts of Singapore.

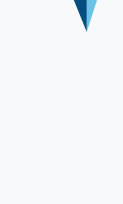

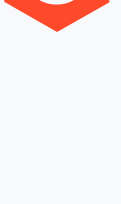

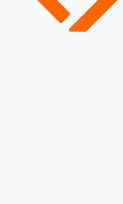
